Below you will find various updates, news, and reminders. Your attention to these matters is appreciated.



Dumpster Day

The fall dumpster day has been scheduled for Saturday, October 18, 2025. The dumpsters will be available to residents from **6:00 AM until 1:00 PM** (unless they are filled earlier). The dumpsters will be in the parking spaces by the playground. There will be a monitor at the dumpsters while they are on site. The role of the monitor is to catch non-residents attempting to dump at SW2, prevent dumping on the ground and not in the containers, and to prevent inappropriate materials from being dumped.

Items not allowed include hazardous wastes (gasoline, oil, propane, paints, Freon, etc...), AC units, car tires, brush and tree stumps, rocks, cement, and car batteries. If you are going to dump lawn mowers or other such equipment, they must be drained of all oil and fuel. **You must have proper proof of identification and SW2 residency with you.**

Update Regarding Proposed New Surveillance Camera Rule

There is a requirement to provide notice to owners and to provide a ten day comment period. Comments were received from Unit Owners and a committee was formed to revise the suggested new rule based on the comments received. The committee has been working on revising this proposed rule. Once the Board approves of a revised version of this proposed rule, it will again be sent out to owners for comment. In the meantime, please do not install any cameras outside of your unit as Unit Owners are not allowed to alter the exterior of a unit without board permission. Thank you.

Some routine reminders....

There will be no delayed trash pickups for the remainder of the year.

Political Sign Policy Reminder - only one political sign - regarding candidates for election (town/city, state or federal) or political issues such as budgets, town/city rule/law changes - is allowed to be displayed at each unit. Signs are allowed to be displayed 14 days in advance of voting/election matters. Signs must be removed within 48 hours of the vote/election. Signs must be no bigger than 2'x 2'. Signs cannot be placed on the common or limited common elements (example: on steps, in driveway, on front lawn). Signs may be displayed inside a Unit window only.

It is legal for politicians to ring doorbells throughout the Association.

LANDSCAPE REPORT SEPTEMBER 2025

LANDSCAPE NOTE: We have seen some spotted lantern flies in our development. Our arborist is aware of this and is monitoring the situation. These insects attack some trees and shrubs. If you see them in your area, please notify Kim and our arborist will check it out and see if any treatments are necessary at this time. Attached is a Bartlett Leaflet with information on the spotted lantern flies.

When you plant flowers around tree mounds and the edges of shrub beds, make sure the flowers do not grow past the mound into the edges of lawn areas. Please trim the flowers before they grow over the edges. Our landscapers have to weed whack these areas and are not responsible for any damage to the flowers that grow into lawn areas.

Please do not remove a dead shrub you want us to replace. Let Kim know you have a dead shrub. If you remove a dead shrub on your own, we will lose the warranty for the new replacement shrub.

GONZALEZ LANDSCAPING: Because of the dry conditions spot mowing is being done. Regular mowing will resume as soon as weather conditions improve. Many of the lawns have been affected by the dry conditions and lack of watering. Our next reseeding will be in the spring. However, aeration and overfeeding work will be done in early October. The fall shrub replacement list has been given to Gonzalez and any future requests will be put on the spring shrub replacement list. We anticipate shrub replacements and plantings of mums to be the last week of September. Our landscaper leaves a note at the units who receive new shrubs to request that you water them. If the shrubs die due to lack of watering, we will not receive a warranty for that shrub. Weekly services include weeding and policing of trash.

BARTLETT TREE SERVICE: Our arborist took some soil samples of our maples and found that certain maples had some nutrient deficiencies. He recommends a prescription plan to treat these maples in the spring. Over 40 tree of heaven trees (an invasive tree that spotted lantern flies lay their eggs on) were removed, and the stumps treated so the trees do not grow back. This was a costly project over \$6,000 but had to be done to cut down the number of spotted lantern flies.

LAWN DOCTOR: We have only one lawn application left, that is winter fertilizer and lime. We are anticipating this service to be done in early October.
